Membership checks Sportcentrum Olympos



Users of the Sportcentrum Olympos facilities (this includes Kalymnos and Kratistos) will have to be able at all times to show their card or receipt in order to prove that they are entitled to make use of the facilities and / or to take part in the various sports programmes offered (courses, free sports, group lessons, student sports clubs).

If, upon a check, you are unable to present valid proof of participation, this will be regarded as the unauthorised use of the facilities.

Sportcentrum Olympos staff carry out regular checks.

Various checks are carried out depending on the type of sports programme:

• Courses

Participants are checked by their **instructor**. The instructor is regularly provided with a list of the participants in the course in order to be able to check the validity of their participation. Participants always have to show their OlymPas at the start of a course period.

• Group lessons

Participants are checked at the Service Desk prior to the start of the group lessons. Your OlymPas will be checked and you will be issued a ticket for the relevant lesson.

• Free sports / lessees / guests

Free sports participants (beach volleyball, climbing, fitness, strength sports, squash and tennis) are checked by scanning the validity of the OlymPas or by checking the receipts.

Beach volleyball and **tennis players** have to place their OlymPas (or their receipts) on the reservation board outside.

If you want to enjoy our **fitness** and **squash** facilities, your OlymPas (in case of squash this may also be your receipt) must be placed in the card holders available at the gym and the squash courts.

If time allows, squash players will also be checked at the Service Desk when enquiring about the number of the court they have booked.

Student sports clubs

Staff of Sportcentrum Olympos as well as board members of Sports Council Utrecht and board members of the sports clubs check the validity of student sports club members. Usually the athletes are checked at the start of their activities so as not to disturb practices or matches.

• Olympos Futsal League and 7-a-side League

During the Olympos Futsal and 7-a-side leagues, it will be checked as to whether participation is based on the OlymPas or a team fee. If participation is based on the OlymPas, all the team members will be checked on the possession of an OlymPas. If participation is based on a team fee, there is no obligation to carry out further checks. The team members will, however, be asked to register with Sportcentrum Olympos if they have not done so yet. No further additional costs apply.
